"CERTIFICATE COURSE IN MODERN PHARMACOLOGY "
FOR THE HOMOEOPATHIC PRACTITIONERS'
IN THE STATE OF MAHARASHTRA

PREAMBLE

The Government of Maharashtra has decided to start a certificate course in Modern Pharmacology for Registered Homoeopathy Practitioners which is notified through Government Resolution No. एमएचसी २०१४/ प्र. क्र. ३०८/१४/ शिक्षण-२, दि. १३ ऑगस्ट २०१४. The Government of Maharashtra has directed Maharashtra University of Health Sciences, Nashik to conduct Certificate Course in Modern Pharmacology in its affiliated Medical Colleges. After acquiring this qualification, Homoeopathic Practitioners will be allowed to use Modern Medicine in their medical practise to the limited extent. Accordingly, as per direction of Maharashtra Act no. 19 promulgated in the year 2014, necessary amendments in Maharashtra Homoeopathic Practitioners Act, 1960 & Maharashtra Medical Council Act, 1965 is carried out by the State Government of Maharashtra.

This course will be conducted in Government / Private Medical Colleges affiliated to MUHS upto intake capacity 50 students per College. This course will be of one year duration and it will be a part time course. All necessary fees will be announced by the Maharashtra University of Health Sciences Nashik, from time to time.

The Homoeopathic Practitioners, who are registered with the Maharashtra Homoeopathic Council, Mumbai will only be allowed for admission to this course. The Registrar MUHS will be the Competent Authority for admission process of this course.

Online Application Form is available on University website i.e. www.muhs.ac.in. The syllabus of the said course and fee structure is also available on MUHS website.

After final scrutiny of the applications submitted to the University, the list of candidates will be published taking into account of seniority of their registration with the Maharashtra Homoeopathic Council and following the reservation policy of the Government of Maharashtra. Accordingly, the candidates are instructed to take admission to the allotted colleges.

1. INTRODUCTION

The admission process for the selection of Registered Homoeopathic Practitioner candidates for Certificate Course of Modern Pharmacology in the State of Maharashtra for academic year 2020-21 will be conducted by the Competent Authority appointed by Government of Maharashtra. The Government/Private Medical Colleges who are affiliated and approved to conduct this course will have intake capacity of 50 students per College. The Competent Authority shall devise the system of selection of candidates. These procedures shall be governed by directions specified by the Government of Maharashtra and Maharashtra University of Health Sciences, Nashik.

2. DEFINITIONS

- 2.1: "**Application Form**" means prescribed form to be filled by the candidate for appearing at admission process. Information submitted by the candidate with the application form will be considered as valid information.
- 2.2: "**Appeal Committee**" means the Admission Committee setup under the Chairmanship of the Competent Authority. It shall deal with the representations submitted by the candidate(s) relating to grievances of the candidate(s) with regard to admission process.
- 2.3: "**Competent Authority**" means the authority designated or appointed by the Vice Chancellor as per directions of the Government of Maharashtra to conduct admission process. The Competent Authority will supervise and control the selection process for the admission to this course and act as a Chairperson of the "Appeal Committee" for representations submitted by the candidates. The Competent Authority will issue necessary executive instructions for implementation and provide relevant information to be published or communicated.
- 2.4: "**Council**" means Maharashtra Homoeopathic Council.
- 2.5: "**Government College/Government Institution**" means College/Institution which is governed or aided by the Government of Maharashtra/Central Government/ local self-Government i.e Govt./Govt. aided/Municipal Corporation.
- 2.6: "**Affiliated Medical Colleges**" Means the Colleges / Institutes which are affiliated to the Maharashtra University of Health sciences, Nashik for the Academic Year of the admission.
- 2.7: "**Intake Capacity**" in any particular College / Institution means the 'minimum number of seats' permitted by the regulatory authorities i.e. Government of Maharashtra and/or Maharashtra University of Health Sciences, Nashik.
- 2.8: "**Nomadic Tribes (NT)**" means Nomadic Tribes as specified and laid down by the Government of Maharashtra.
- 2.9: "**Other Backward Class (OBC)**" means Other Backward Class as specified and laid down by the Government of Maharashtra.

- 2.10: **“Physically Handicap (PH)”** means physically handicap as specified and laid down by the Government of Maharashtra
- 2.11: **"Preference Form"** means the online form containing essential details of the candidate. In this form the candidate has to give his choice of college in preferential order for selection of college.
- 2.12: **“Scheduled Castes (SC)”** means Scheduled Castes as specified and laid down by the Government of India and as recognized in the State of Maharashtra.
- 2.13: **“Scheduled Tribes (ST)”** means Scheduled Tribes as specified and laid down by the Government of India and as recognized in the State of Maharashtra.
- 2.14: **“Special Backward Category (SBC)”** means Special Backward category as specified and laid down by the Government of Maharashtra.
- 2.15: **“Vimukta Jati (De-Notified Tribes) (VJ/DT)”** means Vimukta Jati as specified and laid down by the Government of Maharashtra.
- 2.16: **“Socially and Educationally Backward (SEBC)”** means Socially and Educationally Backward Classes of Citizens (SEBC) includes the Maratha Community declared to be Educationally and Socially Backward category (ESBC) in pursuance of the Maharashtra State reservation (of seats for admission in educational institutions in the State and for appointments or posts in the public services under the State) for Educationally and Socially Backward Category (ESBC) Act, 2014 as per Maharashtra Act No. LXII of 2018 Dated 30th November 2018.
- 2.17: **“ Economically Weaker Section (EWS)** means Economically Weaker include person who are not covered under the scheme of reservation for SCs, STs, and OBCs and whose family has gross annual income below Rs.8,00,000/- as per Government resolution of General Administration Department ROD -4019/C,R31/16-A Dated 12 February 2019.

*** Special Note:- In case if any court matter is arised in respect of SEBC & EWS eservation during admission process of 2020-21, then University shall have right to change reservation norms as per Hon’ble Court judgment.**

3. ELIGIBILITY FOR ADMISSION

- 3.1: The candidate must be a registered Homoeopathic Practitioner in Maharashtra State under Maharashtra Homoeopathic Practitioners Act, 1960. **The Practitioners who are registered other than Maharashtra state shall not be eligible for admission.**
- 3.2: The candidate shall be registered and shall have renewed registration in due course of time. The Registration should have been renewed and valid till the last date of application. **The**

candidates, whose registration is not renewed / valid, will not be considered for admission process.

3.3: Admissions will be given as per seniority of the registration number in the State Register given by the Maharashtra Homoeopathic Council, Mumbai.

3.4: Reservation policy will be followed for admission as per the existing rules of the Maharashtra Government. The physically challenged candidates may claim reservation by producing valid certificate to that effect issued by the competent authority.

4. APPLICATION FORM & INFORMATION BROCHURE :-

4.1: This information brochure for the Certificate Course of Modern Pharmacology is available on University website i.e., www.muhs.ac.in. Candidates are required to submit online application form to be filled with due care and required to submit the print out of the online submitted form along-with necessary documents to the University.

4.2: The candidates who had registered in Maharashtra Homoeopathic Council, Mumbai and whose registration number is from 01 to 60,000 are eligible to apply for the academic year 2020-21. The candidates, whose registration number is above 60,000, are not eligible and shall not apply for this year i.e. for the academic year 2020-21. Their applications will not be considered. Also, the already admitted candidates for the said course during previous the Academic Year will not be considered eligible for admissions during this process.

4.3: The candidates are required to submit the application form online by 21/08/2020. Therefore they are required to take out a print out of online submitted application form and there-after submit the said print out alongwith all necessary self attested documents to the University by 31/08/2020. The forms received after the prescribed cut off date as well as which are incorrect, incomplete and wrongly filled will not be considered. **Application fees are non-refundable.**

4.4: Each candidate is required to provide minimum 01 & maximum 28 choices for admission centres. Option / Choices once given cannot be changed in any circumstances. The list of authorised & affiliated Colleges is attached herewith as “Annexure-C”.

4.5: Reservation Rules for admission shall be as per existing policy and rules of the Maharashtra State Government.

4.6: A candidate, who had been allotted admissions according to his / her choice(s), will not be allowed to change or opt for new choices. He/ She will have to take admission in the allotted College.

- 4.7: In case if a candidate denies to take admission as per his/her preference, then his/her application will not be considered for that particular academic year. He/ She will have to apply as afresh candidate in the next academic year. The vacancy created in such cases will be carried forward for next candidate in merit.
- 4.8: The University reserves every right to amend, alter the complete or part rules at any stage without intimation to the candidates.
- 4.9: Representations against such changes shall not be entertained and will not be communicated separately.

5. NECESSARY CERTIFICATES

- 5.1: No original certificates are required to be submitted along with application form. Self attested copies of following certificates should be submitted with the application form
- a) Copy of Birth Certificate / Matriculation or SSC passing certificate or School / College leaving certificate, having date of birth mentioned on it.
 - b) Degree / Diploma Certificate / PG Degree Certificate
 - c) Maharashtra Council of Homoeopathy Registration Certificate
 - d) Constitutional reservation claim:-
 - i) Caste Certificate
 - ii) Caste Validity Certificate
 - iii) Non Creamy Layer Certificate (for VJ/DT (A), NT (B), NT (C), NT (D), SBC , OBC,SEBC & EWS valid up to 31/03/2020.
 - iv) Physically handicap documentary proof.
 - e) NOC from Maharashtra Council of Homoeopathy (Original)

6. PREPARATION OF ADMISSION LIST & ADMISSION OF CANDIDATES

- 6.1: The Competent Authority will scrutinise all forms received with the help of Admission Committee.
- 6.2: Collegewise admission list will be prepared as per seniority in registration alongwith constitutional reservation policy and choices given by the candidates.
- 6.3: The collegewise admission list will be declared on the University website i.e. www.muhs.ac.in. as per time schedule decided by the University from time to time.
- 6.4: The candidates, whose name is included in the said list, are required to approach the concerned College for taking admission within prescribed time period.

07. LEGAL JURISDICTION

All disputes pertaining to conduct of admission process and selection shall fall within the jurisdiction of Bombay High Court, Mumbai. The Competent Authority shall be the legal authority in whose name the MUHS may sue or may be sued. All process in writ petitions shall be issued to and served on the Competent Authority.

08. SPECIAL NOTE

It is made clear that the decision of running Certificate Course of Modern Pharmacology has been challenged by the Indian Medical Association, Pune by filing a Writ Petition (No. 7847/2014) and Civil Application No. 3368/2015 in Writ Petition No. 7847/2014. The said Civil Application has been disposed off vide order dated 14/03/2016 denying to grant stay on the operation and execution on the decision of the State Government and MUHS. However, the court has made it clear that the admission to the said course as well as any further action shall be subject to final orders that shall be made in WP No. 7847/2014. The court has further made it clear that neither the State Government or the candidates shall claim any equity in case of the decision goes against the State Government and MUHS. Hence, the entire admission process to this course is subject to the decision of the Hon'ble High Court in W.P. No. 7847/2014 or any other petition which is pending for adjudication at present.

ANNEXURE - A

CONSTITUTIONAL RESERVATIONS

- 1) The candidates recognized by the State of Maharashtra as belonging to the following Backward Classes, shall alone be eligible to claim admissions as against the seats reserved for such backward class categories. These Backward Class categories are as follows as per Govt. Gazette Notification dated 01/08/2006 issued by Govt. of Maharashtra.

1	Scheduled Castes and Scheduled Caste converts to Buddhism (SC)	13.0 percent
2	Scheduled Tribes (ST)	7.0 Percent
3	De- notified Tribes (A) (VJ- A)	3.0 percent
4	Nomadic Tribes (NT - B)	2.5 percent
5	Nomadic Tribes (NT - C)	3.5 percent
6	Nomadic Tribes (NT - D)	2.0 percent
7	Other Backward Category (OBC)	19.0 percent
8	Socially and Educationally Backward (SEBC) *	16.0 percent
9	Economically Weaker Section (EWS) *	10 percent
10	Open Category	24 percent
	Total	100 percent

N.B.: 1) As per Government Circular from Social Welfare, Cultural Affairs and Sports Department No. CBC- 1095/WS/264/BCW-5 dated 24th October 1995, applicants belonging to Special Backward Category (SBC) are to be considered as OBC candidates.

2)*: In case of any change in Reservation Policy by the State Government, it shall be applicable for admission process of A.Y.2020-21.

Provided that, if candidates belonging to the Scheduled Castes, Scheduled Tribes, De-notified Tribes (A), Nomadic Tribes (B), Nomadic Tribes (C), Nomadic Tribes (D) or Other Backward Classes are not available to fill in the seats reserved for the said castes, Tribes or classes, in the same academic year, the seats shall be filled up, in such a manner as may be specified, by the State Government from time to time.

- 2) Reservation policy will be implemented College wise.

- 3) Candidates belonging to aforesaid Backward Class categories including SEBC will be required to submit the Caste Certificate and the Caste/Tribe Validity Certificate.
- 4) Caste Certificate issuing authority: - Caste certificate stating that the caste is recognized under a particular backward class category in Maharashtra State is issued by Sub-Divisional Magistrate / Executive Magistrate /Metropolitan Magistrate in Maharashtra State.
- 5) The Caste/Tribe validity Certificate Issuing Authorities are as follows:-
 - a) For Candidates belonging to Scheduled Caste, Scheduled Caste converts to Buddhism, Vimukta Jati (A), Nomadic Tribes B, C & D, and Other Backward Class, Caste Validity Certificate is issued by Divisional Caste Scrutiny Committee of respective Divisional Social Welfare Office (Mumbai, Pune, Nashik, Aurangabad, Amravati, Nagpur and Latur).
 - b) For Candidates belonging to Scheduled Tribe the Tribe Validity Certificate is issued by Commissioner/Jt. Commissioner, Tribe Scrutiny Committee of respective Region [Kokan (Thane), Pune, Nashik, Aurangabad, Amravati, Nagpur, Nandurbar and Gadchiroli].
- 6) The candidates who have claimed the Constitutional Reservation in the original Application Form must submit Caste Validity Certificate at the time of filling the Preference Form, failing which the category claim, will not be granted.
- 7) NON-CREAMY LAYER: A candidate belonging to ‘Creamy Layer’ amongst the categories (3), (4), (5), (6), (7), (8) and (9) must note that the provision of reservation is NOT applicable to him/her. A candidate claiming benefit of reservation under the categories (3), (4), (5), (6),(7), (8) and (9), above will be required to produce Non- Creamy Layer Certificate in the name of candidate as specified in the Government resolution No. सीबीसी १०/२००८/प्र.क्र.६९७/मावक, दिनांक १३/०१/२००९. The certificate in prescribed proforma (Annexure - E) stating that it is valid upto 31/03/2020 needs to be submitted.

The Non-Creamy Layer Certificate is issued by Sub-Divisional Officer/Deputy Collector/Collector of the district and shall be produced in any case on or before the last date of filling up of Preference Form, failing which the category claim will not be granted

- 8) Admission under constitutional reservation seat will be governed by the Maharashtra Schedule Castes, Scheduled Tribes, Denotified Tribes (Vimukta Jatis), Nomadic Tribes, Other Backward Classes and Special Backward Category (Regulation of Issuance and Verification of) Caste Certificate Act, 2000 (Mah. Act No.XXIII of 2001). Candidates are instructed to note following provisions of the said act and benefits secured on the basis of false Caste Certificate to be withdrawn.
 - i. Whoever not being a person belonging to any of the Scheduled Castes, Scheduled Tribes, Denotified Tribes, (Vimukta Jatis), Nomadic Tribes, Other Backward Classes or Special Backward

Category secures admission in any educational institution against a seat reserved for such Castes, Tribes or Classes, or secures any appointment in the Government, local authority or in any other company of Corporation, owned or controlled by the Government or in any Government aided institution or Co-Operative Society against a post reserved for such Castes, Tribes or Classes by producing a false Caste Certificate shall, on cancellation of the Caste Certificate by the Scrutiny Committee, be liable to be debarred from the concerned educational institution, or as the case may be, discharged from the said employment forthwith and any other benefits enjoyed or derived by virtue of such admission or appointment by such person as aforesaid shall be withdrawn forthwith.

- ii. Any amount paid to such person by the Government or any other agency by way of scholarship, grant, allowance or other financial benefit shall be recovered from such person as an arrears of land revenue.
- iii. Notwithstanding anything contained in any Act for the time being in force, any Degree, Diploma or any other educational qualification acquired by such person after securing admission in any educational institution on the basis of a Caste Certificate which is

subsequently proved to be false shall also stand cancelled, on cancellation of such Caste Certificate, by the Scrutiny Committee.

- iv. Notwithstanding anything contained in any law for the time being in force, a person shall be disqualified for being a member of any statutory body if he has contested the election for local authority, Cooperative Society or any statutory body on the seat reserved for any of Scheduled Castes, Scheduled Tribes, De-notified Tribes, (Vimuktjatis), Nomadic Tribes, Other Backward Classes or Special Backward Category by procuring a false Caste Certificate as belonging to such Caste, Tribe or Class on such false Caste Certificate being cancelled by the Scrutiny Committee; and any benefits obtained by such person shall be recoverable as arrears of land revenue and the election of such person shall be deemed to have been terminated retrospectively.

9) Offences & Penalties:-

(1) Whoever:-

- (a) Obtains a false Caste Certificate by furnishing false information or filing false statements or documents or any other fraudulent means ; or
- (b) not being a person belonging to any of the Scheduled Tribes, De-notified Tribes, (Vimukt jatis), Nomadic Tribes, Other Backward Classes or Special Backward Category secures any benefits or appointment exclusively reserved for such Castes, Tribes or Classes in the Government, local authority or any other company or corporation owned or controlled by

the Government or in any Government aided institution, or secures admission in any educational institution against a seat exclusively reserved for such Castes, Tribes or Classes or is elected to any of the elective offices of local authority or Cooperative Society against the office, reserved for such Castes, Tribes of Classes by producing a false Caste Certificate; shall, on conviction, be punished , with rigorous imprisonment for a term which shall not be less than six months but which may extent up to two years or with fine which shall not be less than two thousand rupees, but which may extend up to twenty thousand rupees or both.

10) No court shall take cognizance of an offence punishable under this section except upon a complaint, in writing, made by the scrutiny Committee or by any other officer duly authorized by the Scrutiny Committee for this purpose.

11) Offences under Act to be cognizable & non-bailable

Notwithstanding anything contained in the Code of Criminal Procedure; 1973 --

(a) offence punishable under section 11 shall be cognizable and non-bailable;

(b) every offence punishable under this Act, shall be tried by any Magistrate of First Class in a summery way and provisions of sections 262except sub-section(2) to 265 both inclusive of this Code shall as for as possible may be applied to such trial.

12) Penalty for issuing false Caste Certificate.

(1) Any person or authority performing the functions of Competent Authority under this act, who intentionally issues of false Caste Certificate shall earn conviction, be punished with rigorous imprisonment for a term which shall not be less than six months but which may extend up to two years or with fine which shall not be less than two thousand rupees, but which may extend up to twenty thousand rupees or both.

(2) No court shall take cognizance of an offence punishable under this section except with the previous sanction of the Government.

13) Penalty for abetment.

Whoever abets any offence punishable under this Act shall be punished with the punishment provided for in this Act for such offence.
